In the reference 1st cited, Government have issued administrative sanction for establishment of CORS Network for generation of geo-codes for assigning permanent Budhaar number under Bhuseva Project.

2. In the reference 2nd cited, the Director of Survey, Settlements and Land Records, A.P., Vijayawada has requested permission

- i. For conducting Re-survey operations for the entire state in a phased manner duly following statutory procedure laid down in the Survey and Boundaries Act 1923.
- ii. To modify the agreement as per the present policy decision of the Government for "Re-survey" in the place of "Incremental Re-survey".

3. In the reference 3rd cited, the Director of Survey, Settlements and Land Records, A.P., Vijayawada has requested permission for conducting resurvey operations as a pilot project in Jaggayyapeta Mandal of Krishna District with CORS Technology.

4. After examination of the request of the Director of Survey, Settlements and Land Records, A.P., Vijayawada, Government hereby accord permission to conduct resurvey operations as a pilot project in Jaggayyapeta Mandal of Krishna District with "CORS Technology". After completion of resurvey of one village in Jaggayyapeta Mandal of Krishna District, the result shall be presented before the Government for perusal.

5. The Director of Survey, Settlements and Land Records, A.P., Vijayawada is further informed that, one agency had come forward to conduct survey by using "Drone Technology" on free of cost. As a pilot project, one village may be selected to conduct of survey by using both "CORS Technology" and "Drone Technology" and compare the cost involved in both technologies. A detailed study report along with data shall be furnished to the Government for taking further necessary action.

6. The Director of Survey, Settlements and Land Records, A.P., Vijayawada shall take further necessary action in the matter.
