**ORDER:-**

The Inspector of Survey at Head Office, Machilipatnam and the Deputy Inspector of Survey, Vijayawada and Deputy Inspector of Survey (Task Force) at Machilipatnam are hereby directed to closely supervise the above survey work in Takkellapadu Village of Jaggayyapeta Mandal. They are directed to submit daily report Assistant Director, Survey and Land Records, Machilipatnam without fail.

The Officers concerned are requested to relieve the individuals with a direction to report before the Tahsildar, Jaggayyapeta by 08.05.2020.

The Assistant Director, Survey and Land Records, Machilipatnam to compile all reports and give daily reports to this office.

These orders will come into immediate effect and they shall work in Pilot project in Jaggayyapeta mandal till further orders.
