ORDER:

In the reference 1st read above Government has accorded administrative sanction for an amount of Rs.320 lakhs to Establish CORS net work for pilot project in phase-I in Jaggayyapeta Mandal of Krishna District so as to enable to assign permanent budhaar number to the land parcels under Bhuseva project as envisioned by the Hon'ble Chief Minister.

2. In the reference 2nd read above, the Director, Survey Settlements and Land Records, A.P. Vijayawada has requested the Government to accord sanction for the following and to accord Administrative sanction for the phase-I budget of Rs. 20015.95 Lakhs for the F.Y 2020-21.

i) Administrative sanction for 65 base stations and Control centers up gradation and maintenance Component for Phase-I & II along with release of the budget.

ii) Administrative sanction for 11,158 Rovers and release the budget for 3,000 Rovers as resurvey operations will be taken up in Phased manner in the entire state.

3. After careful examination of the proposal, Government hereby accord permission to the Director, Survey Settlements and Land Records, A.P. Vijayawada to Re-Survey of Land in the entire State, utilising the Continuous Operating Reference Station (CORS) technology and to take necessary measures to ensure that the technology and equipment adopted is cost-effective, scalable, accurate and amenable to be utilised for the Land Records system in the State.

4. The Finance Department has agreed to open a separate Head of Account for the Resurvey under 2029 LAND Revenue - 00 -102- Survey & Settlement Operations - 00 - SH (12) - Re-Survey of Land, Detailed Heads - 130/137, 170/174, 170/176, 210/211.

5. An amount of Rs 20000.00 lakhs is provided in Regular BE 2020-21 under the Head of Account for the Phase-I of the Project(2020-21), subject to the following:

(a) To proceed with the proposed capital/non-recurring expenditure component of Phase-I of the Project, duly following the prescribed procedure.

(b) To complete the pilot study initiated in Jaggiapeta mandal, Krishna District and basing on the outcomes send the detailed proposals proposing the recurring expenditure component for the Phase-I of the Project.

(c) To take expeditious steps for obtaining the sanction of grants under the CSS of Digital India Land Records Modernisation Programme (DILRMP) from Department of Land Resources, Government of India.

6. The Director, Survey Settlements and Land Records, A.P. Vijayawada shall take further necessary action accordingly.
